Sopra Steria – Egis consortium is awarded contract to support the Digital European Sky

Paris, January 10th, 2023 - The SESAR 3 Joint Undertaking (JU), a European partnership tasked with the digital transformation of European Air Traffic Management (ATM), has awarded the Sopra Steria-Egis consortium the SESAR 3 Development Support Service (S3DSS) contract. The objective of this project is to support the programme management activities for the implementation and monitoring of the organisation's research activities.

Building on the work of the first SESAR Joint Undertaking, the [SESAR 3 Joint Undertaking](#) is an institutionalised European partnership [created in 2021 between private and public sector players](#). Its aim is to accelerate the delivery of the Digital European Sky (DES) through research and innovation. SESAR 3 JU is defining, developing, and accelerating the market uptake of the most advanced technological ATM solutions to manage conventional aircraft, drones, air taxis and vehicles flying at higher altitudes in a smart, safe and sustainable manner.

The Sopra Steria-Egis consortium brings together a unique combination of locally delivered expertise in managing complex programmes and ATM business knowledge, to contribute to the objectives of Digital European Sky research and innovation programme.
